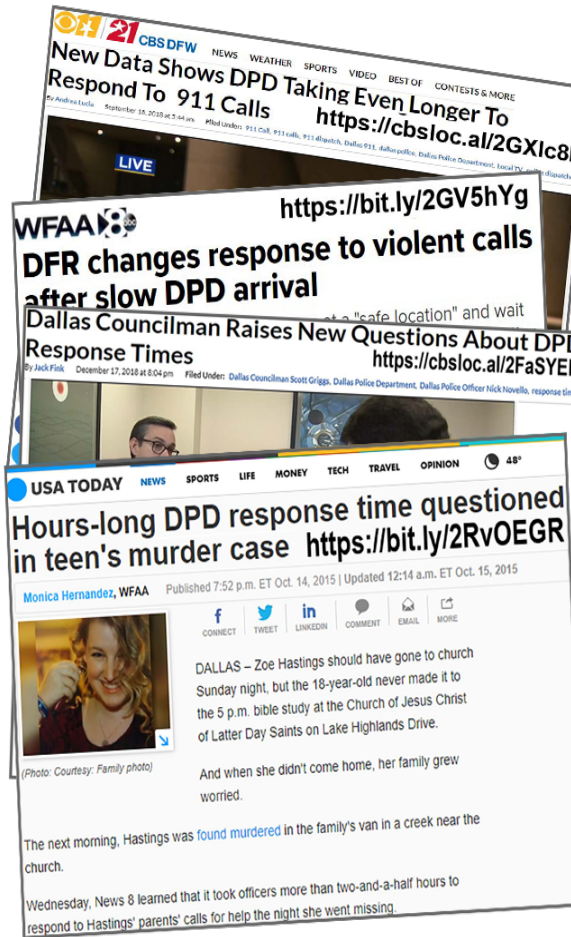

We oppose the CPRB (and CPOB) because (1) it was proposed by a coalition of mostly left-wing groups inherently hostile toward police; (2) Internal Affairs is already in place to monitor police activity by people who understand policing; (3) the CPRB has a built-in inclination to find fault with police in order to justify its own existence and salaries; and finally, (4) the \$1.5 Million up for discussion should go toward augmenting the Police Department before anything else.
